# **Privacy Policy**

SilverCrest Metals Inc. and its subsidiaries (collectively, "SilverCrest") are committed to protecting your privacy and ensuring the security of the personal information that we collect from you. This Privacy Policy outlines how we collect, use, store and disclose personal information obtained through our website. #### Collection and Use of Personal Information

According to Privacy Legislation, "personal information" means any information about an identifiable individual and includes an individual's name, home address, telephone number and email address. In general, you may visit the website and our social media platforms without providing any personal information. However, SilverCrest may collect your name and email address for the following purposes:

#### Disclosure of Your Personal Information

Any personal information that SilverCrest collects will generally not be disclosed to third parties. The intent is that the information will be used for the exclusive use of SilverCrest.
